Contact me any time you have questions about the class or your child's progress. (If you have access to e-mail, that is my preferred way to get messages. If you call the voicemail number, a recording will answer, "Express messaging. Mailbox?" Dial the four digit box number and then press the # key.) I usually check voicemail at the beginning of each day. I will not answer the phone during class time.

I ask all students to share the syllabus and class rules with you. There is a place on the next page where I ask you to verify that they have done this. Students should keep their syllabus and rules pages in their notebook. If you would like a copy for yourself, they are available from my class website, or contact me and I will give an extra one to your child to bring home to you.

The syllabus lists the materials (drafting lead holder, white vinyl eraser, and notebook) that students need for class. These are generally available at any good office supply store and I have descriptions on the website. We also ask every student for a \$10 donation for materials and consumables. Please contact me if you cannot provide these materials right away. **[Note: As a special incentive I will provide the drafting lead holder and white vinyl eraser to students that bring in the \$10 material donation in the first two weeks of school.]**

We love to get parents involved. Do you use technical drawings in your work? Do you have examples that you can donate or allow us to look at? Can you contribute any other materials or time? Please let me know. Either contact me (email is best) or include your contact information on the next page and I'll get with you in a couple weeks.

There are two paragraphs of legal jargon on the attached page. I like to take photos of class projects and the students that work on them. These may be posted around campus or on the class web site. Those two paragraphs are the standard form that OCPS uses to document that you are aware of and give consent for me to do that. If you have questions, please contact me. There are certainly legitimate reasons why you might choose *not* to consent, but I hope you will.
